Appendix 2 – extract from AERA document – Honorary State Veterinary panel

HONORARY STATE VETERINARY PANELS (SVP)

Each State Association shall maintain a SVP comprising a minimum of one Accredited Vet. The precise role and activities of the SVP is dictated by the Terms of Reference issued by the respective State Association, however, generally the SVP should (when appropriate) consult with the State Association on veterinary matters.

HONORARY NATIONAL VETERINARY PANEL (NVP)

The AERA shall maintain a NVP comprising a member from each SVP having been nominated by their respective SVP. The NVP shall be chaired by a member of the NVP in a manner determined by the members of the NVP. The role of the NVP is determined by the Terms of Reference provided by the AERA, however, generally the NVP should (when appropriate) consult with the AERA on veterinary matters.

Appendix 3 – AERA Delegate Report (march 2018)

AERA had our first meeting of the year, with a couple of interesting presentations had, as well as a changing of the guard.

We now welcome our Alamdar Dastani as the AERA Vice President, alongside Peter Bice, and leva Peters as President for this year. leva takes over from Melanie Scott, who was President for four years. As the voting numbers per state is based on the amount of members for the year previously, VERA now have 3 votes allocated to us, a bigger voice for AERA.

AERA are pleased with the payment of invoices, and hopefully the issues we had last year are gone now that AERAspace is doing what it should in regard to affiliation fees.

One of the presentations was regarding how the outside world perceives Endurance. There has been some negativity regarding endurance, especially from overseas, and this presentation was about how we can change people's perceptions of our sport. It is called Social License to Operate. Julie Fieldler, from Horse SA, is planning on sending out a survey to members to find out opinions, and from there pick around 25 people to interview. This will be on an e-blast to members only, so cannot be effected by opinions of those outside of the membership.

We as a state need to reiterate to our Chief Stewards regarding adhering to our rules regarding horse containment. No matter what the ride the horse is entered in to, the fencing must comply with our rules. There was an incident in another state which has highlighted the importance of safety in camp.

There has been one rule change, which was voted on unanimously. Section 15, Vet to Horse ratio:

15.4 For rides of 120 kms or more (in one day), a separate additional treatment veterinarian is required to be present at the ride base.
