9.2 Rides

Ride Reports

Incident forms have been sent to AERA and Surewise for the two incidents which occurred at Snake Valley and Lancefield rides.

Linda reported on the GERZ Championships, which seemed to go well. No invasive treatment conducted, and the riders seem happy. A couple of riders went the wrong way – one was turned around and one returned to base by a different route being subsequently disqualified.

A horse with a different microchip to that recorded in the logbook was identified and information sent to the appropriate State Registrar.

It was identified that a 10km ride was included on the ride flyer for the Legendary-Penn Quilty Qualifier that had not been approved by the SMC. A request has now been received from Ken Bradley for the addition of the 10km event. It was also identified that despite the other rides being requested to be run on the Sunday they are running on the Saturday.

Motion No. 05/04/2022: That the addition of the 10km event and the change of ride day to the Saturday be approved for the Legendary-Penn Quilty Qualifier Ride.

VERA and AERA Calendars to be updated and notification provided to the Ride Organiser.

The meeting was suspended at 9.55 am due to a loss of quorum and was recommenced at 11.12 am.

The ordinary business of the meeting was suspended to discuss the complaint by Jenny Shepherd.

Jenny provided information in support of her complaint including:

- The pre-ride meeting consisted of a big discussion where the head vet said everyone had been challenging the vet decisions during the day
- The CS backed this up and said that people were disrespectful
- Both people advised that this was not going to be acceptable for the following day and that the vets were not to be challenged
- Advice was provided that a panel would be utilised to determine outcomes for lameness
- When Jenny had finished the ride and been TPR'd she walked towards the Head Vet, who was available, but was directed to another vet
- This vet trotted Jenny up and then wanted a re-trot and organised a panel
- This surprised Jenny as she thought her hose was fine
- The vet panel determined that the horse was lame and was vetted out
- One of the vets came to Jenny and said the horse was very lame in the back end
- Jenny's fellow riders were smiling at her and given the thumbs up to indicate the horse was fine
- Jenny didn't think the horse was lame, but she did not question it at the time and left the vet ring
- Jenny and her crew immediately trotted the horse up across some varied and rough terrain, taking a video, showing that the horse was not lame
- Jenny took the video to the Head Vet to show that the horse wasn't lame, and the vet agreed that it was not lame
- Jenny was directed to the CS who said that this incident was not the worst of it all, the whole weekend
 had been a nightmare with people getting vetted out when their horses were not lame and lame horses
 being passed as sound
- To Jenny, the worst of all this was that the horse was not lame
- She left the vet ring as she did not get any result but did not want to be disrespectful and pursue the matter
- Jenny felt that the panel approach should not have been used as the vets did not seem experienced and the head vet should have had the final say
- After returning home, the next morning the horse was running around and rounding up other horses and was not lame at all.
- Jenny felt that if she had been able to go to the head vet for the final trot up, she would have got through the ride

Kerrie clarified that the video taken was of the horse being trotted up after the vet check and not during the vetting. Jenny confirmed this and advised that videoing in the vet ring was not allowed under the rules.

Jenny advised that when she submitted her complaint, she asked that the head vet be contacted straight away so that she could be asked about the situation while she remembered the issue.

Jenny was thanked for her comments and for attending the meeting. Unfortunately, the Chief Steward was not available at the meeting and further investigation would be required. Discussions need to be held with the Chief Steward and the SMC would then determine an outcome. This will be communicated to Jenny. Jenny left the meeting.

Louise Mackey (RO) advised that she thought the comments about what the head vet said at the pre-ride was over-exaggerated and that Judy decided how to run the vet ring as is her right. Any video from outside the vet ring should be disregarded as it does not constitute evidence of what happened in the vet ring.

If Jenny did approach Sandy Little and he made the comments, it is disappointing as he should have upheld the rules and said that the vet's decision is final. If the comments are correct, he could have provided a better explanation and felt it was a breach of confidentiality. It made everyone look like they didn't know what they were doing. It gave Jenny scope to put in an official complaint because of his comments.

Louise also expressed disappointment that the head vet said it wasn't lame rather than saying it was panelled and was vetted out. Everyone knew the vetting times on Saturday as these were on FB and the ride flyer so they knew when they should have been organised.

Louise left the meeting.

The SMC discussed the matter and determined:

- 1. The rules indicate that the vet's decision is final, that any complaints must be made before the rider leaves the vet ring and that the SMC can only determine if the CS has made a mistake in interpreting the rules, which does not apply in this case as the decision was made by the vets.
- 2. Need to talk with the Chief Steward to confirm comments made to Jenny

A meeting will be convened to discuss the matter with the Chief Steward.

The meeting returned to the order of standard business.
